### Duties and Responsibilities

The Young Actors + Young Artists Summer Camp Head Instructor will work closely with the Assistant Instructor, Teen Arts Support Staff and the Center Arts Program Manager. This position will report to the Executive Director.

### **Specific Responsibilities**

- Complete pre-camp training and screening process
- Lead the design process of daily camp activities and review performance piece in pre-camp planning session
- Co-lead and implement daily activities, game, performance and projects throughout camp period
- Responsible to monitor and care for the campers to create a safe and positive environment
- Check campers in and out of program daily

- High School Diploma required, preferred some college or youth program training
- Previous experience with performing and visual arts based programming, activities and/or projects
- Must have experience working with kids, ideally ages 7-10

This is a contractor position running from June 17 through August 9, 2024, Mondays-Friday, from 8:45 am to 4:15 pm. There will be a mandatory paid training day in May and planning day in June, dates to be determined based on availability. Thursday, July 4<sup>th</sup> will be a paid holiday. Compensation is \$1,875 per 2 week session, total of 4 sessions. Location of camp will be at the Art and Culture Center/Hollywood 1650 Harrison Street Hollywood, Florida 33020
